County Issues

Good news first – unexpectedly Worcestershire has been voted the best place for a staycation in the UK – not Devon, Cornwall, Cotswolds, or the Peak District! (study by Auto Finance)

County Hall – has both RAAC and Legionnaire issues – now closed so options are being investigated – Staff are working out of a nearby building owned by WCC: Wildwood.

WCC has a new Management Structure following its voluntary redundancy programme and staff leaving – this is helpful and should bring delivery and policy closer together.

Officers are analysing the impact of the change of government on Worcestershire – for example, WCC was due £209 million over 7 years from the Highways fund, more housing has been mentioned at Parkway, and there is the possible positive impact of adult social care reforms.

Finances: 23/24 Better than expected £19m WCC's overspend is now £4.6m but we still need to be vigilant 24/25. The Higher Need overspending is still an issue. **Savings recently achieved are** due to the LED lighting change, improved waste processing, and an increase in fostering, especially the super fosterers!

Enquiry 773 Cropthorne / Charlton Cemetery Bridge to Jubilee Bridge - road cracking, still on the list for the edge of carriageway repairs. 6th June planned visit. Requested

- 2. identification of issues to get it done
- 3. Indication if it will be funded by WCC if so which funding stream
- 4. If not would parishes Cropthorne/Charlton/Fladbury jointly fund.

Update

It has been determined this is a structures job which needs doing. It will cost 250-400k so will be programmed in for 2025. It is a big job and Jacobs; a sub-contractor will need to be called in. In November when the vegetation has died back the council will add a wall of gabion baskets in the interim. I have asked meanwhile for a white line to be painted along the area to encourage drivers to keep away from the edge. I don't want two large vehicles passing and toppling over. There was a suggestion of temporary lights for two years.

Order made to close Footpath CN-520 Charlton and EV-579 Evesham between Grid Ref: 401632, 242603 and 401896, 242443.- unsafe bridge.

Exemptions: to permit access to any land or premises having a frontage to the highway affected where there is no other form of access; and to allow the necessary works to be undertaken.

Alternative route: South on footpath Charlton CN-517, north-east on Charlton CN-522, north-east then northerly on Evesham EV-577 and vice versa.

The proposed Order will continue in force for a period not exceeding 6 months or until the works which it is proposed to be carried out have been completed, whichever is earlier. However, it is anticipated that the Order will only be operative for 6 months commencing on 22 January 2024. Chasing
